

Activities and Achievements of Panchayati Raj & Drinking Water Department for January 2019 during the year 2018-19

The Panchayati Raj & Drinking Water Department has been entrusted with implementation of various Poverty Alleviation Programmes in the State. The Poverty Alleviation Programmes mainly cater to the needs of rural families living below the poverty line. These Programmes can be grouped under the following five broad categories: -

1. Self-Employment Programme

National Rural Livelihood Mission (NRLM): -

During the current financial year 2018-19 up to January 2019, an amount of ₹27388.07 lakh has been utilized against the total available funds of ₹38481.65 lakh. The utilization of fund is 71% and 92146 numbers of SHGs have been Credit linked against the total target of 1,35,000 numbers of SHGs.

As compared to this, an amount of ₹19675.00 lakh was utilized in the corresponding period of the previous year 2017-18 out of total available funds of ₹32668.00 lakh. The utilization of fund is 60 % and 73989 numbers of SHGs was credit linked against the total target of 80,000 SHGs.

In scheduled areas, up to January 2019 in the current financial year 2018-19 an amount of ₹4547.24 lakh has been utilized out of total available funds of ₹9245.36 lakh. The utilization of fund is 49% and 16029 numbers of SHGs have been credit linked against the total target of 31,651 SHGs

2. Wage Employment Programme

2. Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS): -

During the current financial year 2018-19 up to January 2019 an amount of ₹183826.57 lakh has been utilized against the total available funds of ₹180743.95 lakh. The utilization of fund is 102%. 681.55 lakh person days have been generated against the target of 950.00 lakh.

As compared to this, an amount of ₹192410.00 lakh was utilized in the corresponding period of the previous year 2017-18 out of available funds of ₹193759.00 lakh. The utilization of fund was 99%. 679.66 lakh person days were generated against the target of 900.00 lakh.

In scheduled areas, up to January 2019 in the current financial year 2018-19, an amount of ₹88572.34 lakh has been utilized against the total available funds of ₹85193.88 lakh. The utilization of fund is 104% and 321.63 lakh person days have been generated against the target of 375.41 lakh.

3. **Gopabandhu Gramin Yojana(GGY): -**

It provides additional developmental assistance in all the districts of the State. The principal objective is to provide rural infrastructure primarily Bijli, Sadak& Pani to every revenue village in the districts.

It is a State plan scheme launched in 2006-07 and the entire fund is provided by the State Government.

Expenditure to the tune of ₹20125.25 lakh has been incurred in the current financial year 2018-19 up to January 2019 against the available funds of ₹75287.35 lakh, which constitutes 27%. 9229 number of houses have been completed against the target of 22538.

As compared to this, ₹30498.00 lakh was utilized out of total available funds of ₹69943.00 lakh in the corresponding period of the previous year 2017-18, which constituted 44%. 13785 no. of works were completed against the target 25730

In scheduled areas, up to January 2019 in the current financial year 2018-19, an amount of ₹ 5038.10 lakh has been utilized against the total available funds of ₹24288.25 lakh. The utilization of fund is 21%. 2252 no. of works are completed against the target of 6596.
